Job overview

We are seeking either band 6 or band 7 level applicants to join our team. A band 6 applicant should have experience of approximately 2 years or more with competent experience in most aspects of orthotics and have proven experience of working at band 5 level.

Our community-based service near to Poole Hospital, provides face-to-face and digitally enabled appointments. At our main site, we have a large clinic room for patient assessment and care delivery, alongside a small workshop within the department. You will be required to travel to cover clinics in Bridport and Yeatman hospitals for this post. The post provides the opportunity to work in specialist practice within the areas of foot and ankle, paediatrics, spinal, neuro-rehabilitation and gait analysis. We would like the successful applicant to be an integral part of our team and to bring new and additional skills for compassionate patient care outcomes.

Main duties of the job

Working within the 'Specialist Services' area of Dorset Healthcare as a Senior Orthotist, you will have regular contact with other key teams and professionals to enable you to effectively manage your orthotic patient pathways; having close links to the Podiatry team, Physiotherapy, Diabetes and MSK services as well as the Community Pain services.
